

OFFICIAL RULES

BROTHER INDUSTRIAL LABELING SOLUTIONS QUIZ SWEEPSTAKES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

By participating, each entrant agrees to be bound by these Official Rules and by the decisions of Sponsor, which are final and binding on all matters relating to the Sweepstakes.

1. Sponsor

The Brother Industrial Labeling Solutions Quiz Sweepstakes ("Sweepstakes") is sponsored by Brother International Corporation, 200 Crossing Blvd., Bridgewater, New Jersey 08807-0911 ("Sponsor"). Brother Mobile Solutions is a division of Sponsor.

2. Sweepstakes Period

The Sweepstakes begins at 12:00:00 a.m. Eastern Time ("ET") on August 15, 2026 and ends at 11:59:59 p.m. ET on December 1, 2026 ("Sweepstakes Period"). Sponsor's computer is the official timekeeping device.

3. Eligibility

Open only to legal residents of the 50 United States and the District of Columbia who are at least 18 years old and the age of majority in their state of residence at entry and who, at the time of entry, work professionally in the industrial labeling field within the datacom, electrical, or maintenance, repair and operations ("MRO") sectors as an end user, contractor, manufacturer's representative/rep agency representative, or authorized reseller representative ("Eligible Industry Participant"). Entrants must have permission to participate if required by their employer's policies. Employees, officers, and directors of Sponsor, its parent companies, affiliates, subsidiaries, advertising and promotion agencies, prize suppliers, and any other entity involved in developing or administering the Sweepstakes, and members of their immediate families (spouse, parent, child, sibling, and their respective spouses) and persons living in the same household, whether related or not,

are not eligible. Void outside the stated territory and where prohibited or restricted by law. Sponsor may require reasonable documentation to verify eligibility.

4. How to Enter

During the Sweepstakes Period, visit <https://brothermobilesolutions.com/right-tape-for-every-job/> , provide all requested entry information, and complete any of the three available industrial labeling quizzes. Each quiz contains up to five questions. To earn entry to a quiz, the entrant must complete the quiz in full and answer every question. An entrant who answers any question incorrectly will earn an entry. Each eligible person may earn no more than one entry per quiz, regardless of the number of attempts or perfect scores, for a maximum of three entries total. Completing one qualifying quiz earns one entry; completing two different qualifying quizzes earns two entries; completing all three different qualifying quizzes earns three entries. All required information must be complete and accurate. Entries generated by script, macro, bot, automated process, multiple identities, multiple email addresses, or other means intended to circumvent the entry limits are void. No purchase or payment is required.

5. Entry Conditions

Entries must be received during the Sweepstakes Period. Proof of submission is not proof of receipt. Sponsor is not responsible for lost, late, incomplete, inaccurate, misdirected, delayed, corrupted, or undelivered entries or for technical, network, device, platform, or human errors. If a dispute arises regarding an entrant's identity, the authorized account holder of the email address used to enter will be deemed the entrant, subject to verification. "Authorized account holder" means the natural person assigned the email address by the applicable provider or organization. Sponsor may disqualify any person who tampers with the entry process, violates these Official Rules, acts fraudulently or disruptively, or attempts to obtain entries through unauthorized means.

6. Random Drawing; Odds

On or about December 2, 2026, Sponsor or its designee will conduct a random drawing from all eligible entries received to select three potential winners. The first name drawn will be the potential First Prize winner, the second the potential Second Prize winner, and the third the potential Third Prize winner. An entrant may win no more than one prize; after a person is selected, any of that person's remaining entries will be removed from subsequent

prize drawings. Odds of winning depend on the total number of eligible entries received. Having more qualifying entries increases an entrant's chances relative to having fewer entries, but does not guarantee a prize.

7. Prizes

One First Prize: a \$500 digital Visa gift card. One Second Prize: a \$250 digital Visa gift card. One Third Prize: a \$100 digital Visa gift card. Total approximate retail value ("ARV") of all prizes: \$850. Gift cards are subject to the issuer's terms, conditions, expiration provisions, and restrictions. Sponsor is not responsible for a lost, stolen, misdirected, inaccessible, or fraudulently used digital gift card after delivery to the email address supplied by the entrant. Prizes are nontransferable and no substitution or cash redemption is permitted, except Sponsor may substitute a prize of equal or greater value if an advertised prize becomes unavailable. Each winner is solely responsible for all federal, state, and local taxes and any other expenses not expressly stated.

8. Winner Notification and Verification

Potential winners will be notified at the email address provided with entry and, subject to verification, the applicable digital gift card will be sent to that same address no later than December 4, 2026. Each potential winner must satisfy all eligibility and entry requirements and may be required to provide confirmation or documentation requested by Sponsor. If a potential winner is ineligible, cannot be contacted, a notification or prize email is returned as undeliverable, or the potential winner otherwise fails to comply with these Official Rules, the prize may be forfeited and Sponsor may select an alternate potential winner by random drawing from the remaining eligible entries, time permitting. A person is not a winner unless and until eligibility has been verified and Sponsor confirms winner status.

9. Privacy

Information collected in connection with the Sweepstakes will be used to administer the Sweepstakes, verify eligibility, contact potential winners, deliver prizes, maintain required records, and as otherwise described in Sponsor's Privacy Policy at <https://www.brother-usa.com/privacy-policy>. Any choice to receive marketing communications must be presented separately and is not required to enter or win. Entrants may unsubscribe from marketing communications without affecting an entry.

10. Publicity

Except where prohibited, acceptance of a prize constitutes permission for Sponsor and its designees to use the winner's name, city and state, prize won, and statements relating to the Sweepstakes for advertising, publicity, and promotional purposes in any media without further compensation or notice. Sponsor will not use a winner's employer name or logo without separate authorization.

11. Release and Limitation of Liability

To the fullest extent permitted by law, entrants agree to release and hold harmless Sponsor and its parent companies, affiliates, subsidiaries, advertising and promotion agencies, prize suppliers, and their respective officers, directors, employees, and agents ("Released Parties") from claims, losses, damages, liabilities, costs, or expenses arising out of participation in the Sweepstakes or acceptance, possession, use, misuse, or loss of a prize, except for claims that cannot lawfully be waived. The Released Parties are not responsible for any technical or human error that may occur in the administration of the Sweepstakes or processing of entries. Nothing in these Official Rules limits liability for fraud, willful misconduct, gross negligence where it cannot be limited, or any other liability that cannot be excluded by law.

12. Modification, Suspension, or Cancellation

If fraud, technical failure, unauthorized intervention, force majeure, or any other cause beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, Sponsor may, subject to applicable law, cancel, suspend, modify, or terminate the Sweepstakes and, if feasible, award the prizes by random drawing from eligible, non-suspect entries received before the action or by another fair method. Sponsor will not modify the Sweepstakes in a manner that materially disadvantages entrants after entry except as reasonably necessary to address the affected circumstances.

13. Governing Law; Disputes

These Official Rules and the Sweepstakes are governed by the laws of the State of New Jersey, without regard to conflict-of-law principles. Except where prohibited, any dispute arising from the Sweepstakes or a prize must be brought individually, and not as part of a class or representative action, in a state or federal court located in New Jersey. Entrant waives any claim for punitive, incidental, consequential, or special damages and any right to have damages multiplied or increased, except to the extent such waiver is prohibited by law. Entrant's recoverable damages, if any, will be limited to actual out-of-pocket costs incurred in entering the Sweepstakes, and entrant waives attorneys' fees except where applicable law provides otherwise.

14. General Conditions

Sponsor's failure to enforce any provision does not waive that provision. If any provision is held invalid or unenforceable, the remaining provisions will remain in effect and the invalid provision will be enforced to the maximum extent permitted. Headings are for convenience only. In the event of a conflict between these Official Rules and any advertising or other communication, these Official Rules control.
